

General terms and conditions for participants in the congress and accompanying events

1. Scope of validity

The following terms and conditions exclusively apply to contracts for the sale of congress and event tickets for the booked event "Powerfuel Meeting 2024", which are concluded online, in writing, or orally between Climate Invest AG ("Organizer") and the purchaser of congress/conference and/or event tickets. The number of participants for the event is limited. For further event-specific information, please refer to the event's website

2. Conclusion of contract

The booking person submits a binding order upon completing the registration. The contract is concluded when the participant completes the online registration and has the opportunity on the confirmation page to download their invoice or booking confirmation. In addition, a confirmation email is sent to the participant, and the invoice is sent to the booking person, although this is not required for the conclusion of the contract. For registrations in written form (fax, email, letter) or by telephone, the contract is concluded when the invoice and/or booking confirmation are sent to the booking person.

3. Billing and due date of fees

The fees are invoiced on behalf of the organizer. Invoicing is done in the name and on behalf of the organizer, including the legally applicable value-added tax. Payment is usually made by credit card, in exceptional cases by invoice. All fees are due for payment upon receipt of the invoice/booking confirmation, in accordance with the payment deadline specified on the invoice. Regardless of the specified payment deadline, full payment of the invoice amount is mandatory before the start of the event. In the event of a repeated payment reminder, a processing fee of CHF 30.- will be charged. The processing of online credit card payments is carried out through our partner Stripe (www.stripe.com).

4. Cancellation / Cancellation fees by the participant

The following cancellation conditions apply for cancellations:

Cancellation up to 30 days before the start of the congress: 50% refund of the participation fee.

Cancellation from 30 days before the start of the congress: No refund.

These conditions also apply in case of non-appearance of the participant, even in the event of force majeure, prevention due to illness, accident, or similar reasons. Cancellation must be made in writing by post (Climate Invest AG, Hardturmstrasse 76, CH-8oo5 Zurich) or email (terence.morello@climate-invest.org). The date of the postmark/receipt determines the entitlement to a refund.

In the event of the participant's inability to attend, a substitute person can also be named.

Changes from online to live tickets are possible at any time. The price difference of the participation fee will be invoiced.

For changes from live to online tickets, the following rebooking conditions apply:

For rebooking up to 14 days before the event, the price difference of the participation fee will be refunded. For rebooking from 14 days before the event, no refund of the participation fee will be made.

Bank charges for chargebacks by the bank are generally borne by the credit recipient.

5. Performance reservations

If, based on the organizer's experience, it becomes apparent that the event may not achieve the desired success for the purchaser of congress and/or event tickets due to insufficient participants, the organizer reserves the right to postpone or cancel the event to a more favorable time.

In the event of unforeseen circumstances that cannot be avoided even with the reasonable care of the contracting parties ('force majeure'), such as natural disasters, strikes, plagues, epidemics, pandemics, energy supply or operational disruptions, energy shortages, official orders, legal prohibitions, labor disputes, or other cases of force majeure that make the scheduled execution of the event impossible, there is no entitlement to a refund of the participation fees or compensation for other (financial) damages.

Furthermore, the organizer is entitled to:

- · Cancel the event before the official start.
- Reschedule the event. If participation is not reasonable, the participant must provide evidence that this results in a scheduling conflict with another event they have already booked. The participant is entitled to terminate the contract within a period of 14 days after notification of the necessary rescheduling.
- Shorten the event. The participant is not entitled to terminate the contract or withdraw. There is no entitlement to a reduction of the agreed-upon remuneration.

In all cases, the organizer is obligated to inform the participant as early as possible in text form about the circumstances and the measures to be taken by the organizer. The assertion of claims for damages is excluded in any case for both parties. There is no entitlement to reimbursement of travel and accommodation costs as well as loss of earnings.

6. Hotel reservations, disclaimer of liability

The organizer only acts as an information intermediary for hotel reservation services and, therefore, assumes no liability. Rebookings/cancellations are to be made directly with the hotel and are the responsibility of the booking person. The cancellation conditions of the respective hotel apply.

7. Event website, disclaimer of liability

The most current event program can be found on the event website. Program changes are reserved and do not entitle the purchaser of congress and/or event tickets to terminate the contract.

The organizer assumes no liability for the content of third parties, such as presentation files, abstracts, and/or other comparable content. The legality and accuracy of the content, and thus the liability, solely lie in the responsibility of the authors of these contents. All logistical content, structures, and layouts are subject to the copyright of the organizer. These may not be used in any other context without prior written approval from the organizer.

8. Corporate veil

The organizer acts as a mediator for the offered event program and assumes no liability for it. The sole liability lies with the respective service provider. Participation in the activities of the accompanying program is at your own risk.

The organizer is otherwise liable for injury to life, body, and health only in the case of grossly negligent and intentional misconduct on the part of itself, its legal representatives, and agents. For other damages, the liability of the organizer, its legal representatives, and agents is limited to intentional and grossly negligent conduct unless essential contractual obligations are violated.

9. Use and storage of data

The data provided by you will be used exclusively for contract fulfillment and/or for sending information about events organized by Climate Invest AG. In addition, the organizer may send newsletters about similar events to the provided email addresses.

You have the option to block, correct, or delete your contact information for newsletters sent by us at any time. Participants are hereby informed that photographs, videos, and audio recordings of participants may be taken at the congress and can be published through various channels (web, trade journals, and/or other publications) after the event. Participants agree to the use or publication of these recordings by registering and accepting the general terms and conditions.

Digital participation in the conference or event: The regulations described under §9 also apply to participants of the digital conference.

10. Applicable law, jurisdiction

Swiss law exclusively applies. Jurisdiction: 8005 Zurich, Canton of Zurich, Switzerland

11. Final clause

If one or more provisions of this contract are or become wholly or partially invalid, the contract remains otherwise effective. Ineffective provisions are to be replaced by those that come closest to the purpose intended by the parties.
